- 2) Juried rib judging will begin at 2:30 p.m. People's Choice will begin promptly at 3:00 p.m. inside 45 Main St.
- 3) There is a mandatory meeting at 9 a.m. for team captains to go over rules and draw for juried judging time.
- 4) Juried judging will be based on Kansas City Barbeque Society rules. However, this is not a KCBS sanctioned event. See www.kcbs.us for more information. You will be judged on: flavor, texture & appearance.
- 5) People's Choice will be judged by the general public.
